FOR THREE YEARS OLD AND UPWARD By subscription of \$50 each which should accompany the nomination, \$350 to pass the entry box and \$350 additional to start with \$75,000 guaranteed, (which includes \$25,000 FTBOA Fund for Registered Florida Breds) with 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. FTBOA Fund monies to be distributed as follows; \$12,500 for the first registered Florida Bred to officially finish; followed by \$8,500 for the second registered Florida Bred; ending with \$4,000 for the third registered Florida Bred. Weights: Three Years Old, 115 lbs. Older, 123 lbs. Non-winners of a Sweepstakes at one mile or over on the turf since January 1, 2009, 2 lbs.; \$11,200 at one mile or over since then, 4 lbs.; \$10,200 at one mile or over since then, 6 lbs. (Maiden, Claiming and Starter races not considered in estimating weight allowances) Starters and riders to be named through the entry box by the usual time of closing. This field will be limited to twelve starters. In the event more than twelve pass through the entry box, the twelve starters will be determined with preference given to Grade I, II or III Stakes winners in that order, then those that have accumulated the highest turf earnings in 2008-09. For those that enter and are eliminated under these conditions, the nomination and entry fees will be refunded. SUPPLEMENTARY NOMINATIONS OF \$2,000 EACH (which include entry and starting fees) CLOSE TUESDAY, APRIL 28, 2009 BY THE USUAL TIME OF CLOSING.
