

2025/2026 TAMPA BAY DOWNS STALL APPLICATION

NOVEMBER 19 TO MAY 3

*Apply only for the amount of stalls you can readily fill

-ATTENTION TRAINERS-

- 1. Bagged shavings to be used ONLY, per EPA regulations.
- 2. No more than twenty-five percent (25%) of any stable's horses may be Maidens. This ratio must be maintained the entire meeting!
- 3. Six-year-old maidens and older may not start at the meeting or be stabled on the grounds.
- 4. This application will not be considered unless all items are properly completed; the reverse side is signed by the applicant; and it is received NO LATER than SEPTEMBER 15, 2025. A copy of VALID WORKMEN'S COMPENSATION MUST BE ATTACHED.
- 5. Barn area opens for horses October 27, 2025. Ship in between the hours of 8:00 a.m. - 5:00 p.m. only, except for special arrangement with Racing Secretary.
- 6. First day of training will be October 29, 2025.
- 7. Foals of 2024 will not be permitted on the grounds.
- 8. Pony stalls allotted for stables of 25 or more only.
- 9. No stalls are to be used as feed rooms. Trainers are allotted one tack room per five stalls with a non-refundable \$25 key charge. Additional rooms (Pods) available with a \$300 refundable damage deposit and an additional \$200 per month.
- 10. No washing machines will be allowed in the Barn Area per EPA regulations.
- 11. Only wash pads shall be used for bathing all horses, including hosing off of feet, any poultice or cleaning of any equipment, bandages, saddle towels etc. Poultice should be cleaned from wash racks so it does not clog up the drains. Drains must be kept clean at all times. Noncompliance will result in major fines and possible ejection from the grounds for this environmental violation. All horses MUST have nozzles, no exception.
- 12. ALL TRAINERS ARE RESPONSIBLE FOR THEIR EMPLOYEES CONDUCT - FAILURE TO FOLLOW RULES AND/OR GUIDELINES WILL RESULT IN FINES AND/OR LOSS OF STALLS.
- 13. Please be aware that Tampa Bay Downs will follow all CDC and AAEP recommendations regarding the health and safety of all participants throughout the season. Please check Tampa Bay Downs Social Media pages or watch for TEXT alerts for the latest protocol.
- 14. All horses entering in claiming races must have a current negative Coggins Test on file.

IMPORTANT NOTICE: Stalls are allotted solely as an accommodation to owners and trainers in order to encourage full fields at Tampa Bay Downs, which by the allocation of stalls expects the full participation of the applicant for the duration of the 2025-2026 Race Meeting. Lack of participation or early departure may result in a reduction of stall allocation for future race meetings. Any claimed horses need to fit into your allotment.

Tampa Bay Downs reserves the right to conduct out-of-competition testing on all horses stabled on the grounds of the association. There will be no dogs or wildlife of any kind including, but not limited to, birds, chickens, roosters or winged animals on the premises. Equine companion animals must share a stall with an approved Thoroughbred.

TAKE NOTE: All horses that will be stabled or intend to race at Tampa Bay Downs, Inc., must show proof that they have been tested negatively for Equine Infectious Anemia (Coggins Test). HISA requires that all horses be vaccinated for EEE/WEE/WNV, rabies, and tetanus within the previous 12 months and EIC/EHV within the previous 180 days. Verification of these vaccinations must be submitted to Security upon arrival.
